AMENDED
ORDER EXTENDING IMMUNITY

THIS MATTER having been opened to the Court by Jeffrey R. Surenian and Associates, LLC, Jeffrey R. Surenian, Esq. and Michael J. Edwards, Esq. appearing on behalf of the *participating* municipalities that are members of the Vicinage 13 Municipal Group (hereinafter “declaratory plaintiffs”), who seek an extension of immunity from Mount Laurel lawsuits and that are identified on Exhibit A attached hereto; and the Court having determined that it is appropriate to extend immunity to the declaratory relief plaintiffs: and the Court being satisfied that no declaratory plaintiff is “determined to be constitutionally noncompliant” and should

therefore be divested of immunity; and the Court having considered the pleadings and related papers filed in this matter; and good cause appearing.

IT IS on this 19th day of January, 2018, ORDERED as follows:

1. The Court hereby finds that no declaratory plaintiff in the above referenced matter is “determined to be constitutionally noncompliant”.
2. The Court hereby extends immunity for all declaratory plaintiffs through ~~April 1, 2018~~ June 30, 2018
3. Counsel for the declaratory plaintiff shall provide all parties on the Service/Notice List with a copy of this Order within seven (7) days of receipt.
