#### DISCUSSION

Flag Poles on Borough Properties

Council Member Ead discussed in detail how the additional Flag pole idea with placement on the East side of Best Lake surfaced through the Traffic and Beautification Committee. She also mentioned the Traffic and Beautification Committee always stays within their budget and explained where the money would come from to fund this project.

Council Member Martino agrees with the additional flagpole idea but feels a better location would be on the West side of Best Lake.

Council Member Hayeck and Council President Jubin expressed their agreement with Traffic

and Beautification Committees recommendation of placing the additional Flagpole on the East side of Best Lake.

Council Member Robinson expressed her opinion on the additional flagpole. Mayor Balla noted he prefered to see the flagpole located on the West side of Best Lake near the Library to avoid any DEP restrictions.

#### Relocation of Mobus Field

Mayor Balla discussed other potential locations for Mobus Playground. He is in favor of moving the playground away from the brook to prevent it from getting flooded by water, logs and debris. He suggested moving the playground to the outfield of the existing baseball field and recommends two Bocce Ball courts and a sand volleyball court. Council President Jubin expressed his agreement with the Mayor's suggestions.

Councilmember Robinson questioned if there has been written correspondence between FEMA and the Borough regarding the playground renovation process. OEM Coordinator, Carolyn Solon explained in detail the FEMA reimbursement process. Further discussion relating to the FEMA process and the playground location were discussed in detail amongst Council Members.

### **PUBLIC PORTION - GENERAL DISCUSSION**

- 1. Tracy DiFrancesco, Templar Drive, asked if FEMA was called within the first few months after Mobus Playground was destroyed. Administrator Damato advised FEMA requested the Borough submit a letter of intent in early October. OEM Coordinator, Carolyn Solon explained in detail the FEMA application for reimbursement process. Administrator Damato advised the first onsite inspection with FEMA occurred on March 25<sup>th</sup>. Ms. DiFrancesco asked Council Member Robinson to explain her position in regards to the playground renovations if the Borough did not receive reimbursement from FEMA. Council Member Robinson noted that Administrator Damato addressed her concerns in regards to the process that was followed.
- 2. Bruce Ruck, Lakeview Avenue, applauded the Council for their continuation of the hybrid meeting schedule. He suggested the Council put money aside in the budget for the upkeep of Borough improvements. He expressed some health concerns regarding the possibility of adding a sand volleyball court in Watchung.

Mayor Balla expressed his apologies regarding the recent Council Meeting date changes.
