❖ Watchung Hills Regional High School Referendum

Presentation by Elizabeth C. Jewett, Ph.D. Superintendent, Timothy M. Stys, Business Administrator, Michael Birnberg, Board Member, and Robert Morrison, Board President.

Dr. Jewett detailed the referendum process and discussed anticipated projects to be funded. Mr. Stys stated the goal is to utilize capital monies and have the ability to get debt service aide. He also discussed upgrades to the building and noted security equipment for the school is funded through the school budget and other grants.

Mayor Balla inquired with Mr. Stys on the amount of money annually set aside for the school's capital reserve. Council Members took turns asking their questions on any anticipated cost increases and inquired on the statutory process of scheduling the date for the referendum.

Council Member Martino asked Chief Hart for clarification on a few items regarding the above Ordinance. He suggested adding a buffer to the Ordinance to prevent the Council from having to make changes to it down the line. He also asked Attorney Sordillo for clarification on line 3-1.9 (line 9) of the above Ordinance in regards to the recommendation process by the Police Committee.

Council Member Hayeck provided input on the language of the ordinance and noted the main priority was to meet the structural needs requested by the Police Department. He noted he did not feel the language to add a buffer was necessary at the time.

Council President Jubin also agrees there is no need for additional buffer language to be placed in the ordinance. He also commended the Police Department for all they do for the community.

Council Member Robinson spoke on the process in regards to an up to amount and feels it would have been fiscally responsible to adopt the Ordinance with an up to 21 or 22 officers to cover future bases.
