President's Statement

Health Officers Reports

June and July Reports:

• Bruce Ruck inquired about the status of a raccoon bite. Kevin Sumner informed the Board that the patient went through appropriate treatment. There were no further questions regarding the June and July reports.

Report of Representative to Middle Brook (Commission Report)

COVID-19 was the primary discussion.

Ronald Jubin inquired on the Boards budget. Kevin Sumner expressed that it would be finalized around late November or early December.

New Business

Grants:

• It was discussed that grant funding may have been awarded to all counties, but the Board of Health was not eligible. A small training grant was received for COVID-19 response activities which was primarily used for personnel and equipment. There is an increased need for staffing in order to help with education programs, etc., but this is not covered by the grant.

Schools:

• Ronald Jubin mentioned that he would inform the Mayor and Council at the meeting on August 20th about sending out a letter to Watchung residents in regards to schools and COVID-19.

Health Officer's Report on COVID-19

- Health Officer Kevin Sumner discussed COVID-19 data within the Borough of Watchung. As of August 19th, there were 98 total confirmed cases in Watchung. The ages ranged from 29-97. 60% were female and 40% were male. There have been 15 deaths over the age of 65. Commission wide, there have been 1,014 cases.
- Ronald Jubin discussed reporting numbers online. Kevin Sumner does daily case updates; therefore, it is possible. Caution will need to be taken regarding HIPAA.

Grease Traps:

• Due to COVID-19, not all businesses are open, therefore the BOH has not received all grease trap reports.

Contact Tracing:

• Kevin Sumner reported that the State is coordinating the contact tracing process. Contact Tracers are being assigned to Counties, who will in turn send out to municipalities on assignments.
