#### 1. Call to Order—Roll Call:

- a. The meeting was called to order at 7:31 PM.

- 2. Approval of Minutes: The minutes of the Zoom meeting of 4/26/2021 were approved.

#### 3. Reports:

- a. May 2021 Tree Report
- --General Report--22 trees have approval to be removed with 12 replacement trees
- --EC Site Inspections; Violations—One inspection on tree replacement--Glen Eagles Drive, four properties viewed
- --Ash Trees—The DEP's NJ Urban and Community Forestry Program (NJUCF) offers help with EAB management through grant opportunities to municipalities but has rigorous prerequisites to qualify for the program.
  - b. Planning Board
- --Learning Experience application ongoing with Weldon's main objection being inappropriateness of the daycare establishment on selected site.
  - --Bonnie Burn Proposal—Special meeting for Weds. postponed due to insufficient meeting notice.
  - c. Recycling—Styrofoam; Legacy Books
- --Styrofoam—Borough Council discussed recommendations from EC. Council members were basically supportive but had questions/concerns about frequency of collection and use of DPW. Referred back to EC for specific plan. Farmers' Market suggested as possibility with plan proposal to be presented to the BC for the 6/17/2021 meeting. Members of EC to visit first Farmers' Market and revise proposed Styrofoam plan as needed, payment for employee out of EC budget—need truck, employee, and bags.
- --Legacy Books—Library does not take donated books but Friends of the Library does and is interested in working with the EC—money must go to charity or non-profit such as Friends or PBA—site needed for large bin—police station parking lot suggested—Sustainable Jersey points available.
- d. Green Team—Green Fair, Sustainable Jersey, Farmers' Market--moving towards Sustainable Jersey certification. Charlie Neiss working with Bill Hance. First Farmers' market next Tuesday.

#### 4. Unfinished Business:

- a. Operation Pride—Seedling Giveaway—successful event covered by **Echoes-Sentinel**, 300 trees distributed, Rachel reached out to Forestry Service, Pin Oaks and White Pines leftover and available for free, Rachel obtained 100 and gave away 80 so far—total of almost 400 seedlings given away this month.
- b. Tree Planting—EC and T & B to plant trees in fall on east side of Best Lake—will invite Shari Spero, town arborist, to walk area with members and make suggestions.
  - c. Recommendations sent to Mayor and Council
  - -- That the Borough establish a Styrofoam Recycling Program
- --That the Borough adopt the Sustainable Jersey Green Building Checklist into the Land Development Ordinance so that all applicants before the Planning Board would be required to complete the checklist. (Compliance with the Checklist would not be mandatory.) The Green Team also sent M & C a letter supporting this recommendation.
- d. Ridewise—Green Spot Mobility manages charging station locations and works with municipalities as well as the private sector.
  - e. NJ Clean Energy Program Reminder—appliance recycling—appliance must be working, get money

back. ARCA Recycling: 888-484-8313.

- f. Bamboo in Storm Sewer—still in Valley View drain and observed in another drain and a right-of-way—Are there plans for removal?—Daryl EK will follow up with DPW.
- g. Update on the Council acting on a resolution opposing the Gibbstown Logistics Terminal? Rachel will contact NJ Food and Water Watch to find out if there is a deadline on this.
