2. Minutes for June 26, 2023 Teleconference were approved.

3. Reports

- a. Trees
 - Inspections / Tree Report
 - o 31 trees out of 266 removed trees need to be replaced
 - o 23 tree inspections in July and August
 - o 18 tree removal permits submitted
 - Tree subcommittee will meet to discuss follow-up on replanting
- b. Planning Board
 - No report. No meeting in July and August meeting was a closed session
- c. Recycling:
 - Styrofoam article in Echoes-Sentinel from perspective of Long Hill, who has recycled 6000 lbs so far this year
 - Fishing line program a summary of the program will be included in the fall newsletter and includes a request for community partner to assist the EC with the program.
 - Warren clothing swap Sustainability event started by WHRHS student to combat "fast fashion." Discussed holding the event in Watchung
- d. Green Team
 - Farmer's Market attended by an average of 360 people. Numbers way up this year. Fewer vendors in the summer.
 - Began looking at Sustainable Jersey Certification for 2024

4. Unfinished Business

- a. Best Lake update Doug started a "River-friendly" certification application for riparian zone. Certification has multiple tiers. Comes from NJ Water Supply Authority, Raritan Headwaters, and Watershed Institute. Plantings are doing well in the area.
- b. Boy Scout project –Doug has been working with scout, who has proposed making 6 bird boxes 5 bluebird and 1 purple martin. Maintenance- who? Scout not responsible for maintenance. Maybe draft maintenance plan so there's a written protocol to follow to clean up boxes. Best Lake, Watchung Lake, Philips Field proposed as possible locations. \$600 budget for materials. EC voted unanimously to fund project. Mayor and Council in favor of project.
- c. Weed steamer Sonia spoke with Mr. Cheeseman, head of DPW in Branchburg. Council and DPW here are interested in taking a look at it. Sonia

- will set up a day to go out and speak with him and view a demonstration. Maybe make a shared service?
- d. Preferred Tree List new list is posted on EC website.
- e. Fall Newsletter will be published in late September. Rachel thanked the members who contributed to the article.

- a. Board of Adjustment application discussed the Crown Cadillac application. Doug prepared comments that were submitted to the Board of Adjustment.
- b. River-friendly Certification- See 4.a.
