OPENING STATEMENT: Mayor Keith S. Balla called the meeting to order at 7:30 PM and made the following statement: Under the provisions of N.J.S.A.10:4-6 et seq., notice of the time and place of this meeting was given by way of Special Meeting Notice to the Courier News, Echoes Sentinel, and Star Ledger, and posted at Borough Hall.

Council President Black thanked all three councilmen for their service to the town. He also spoke on how important volunteerism is in Watchung and feels Watchung is one of the best communities in Somerset County. He thanked all the residents for volunteering and dedicating their time and feels they are the backbone of this community.

Councilman Nehls thanked all the employees for their hard work.

Councilman Sopko thanked his family for their support throughout his term. He said he is honored to have served the Borough and appreciates all the Borough employees. He thanked former Councilman Rob Gibbs and Councilman Nehls for their years of service and all the knowledge they have taught him. Councilman Sopko reassured everyone as he leaves office the Borough is in good financial shape and he is proud of the financial strength in Watchung. He thanked the residents for the honor to serve them.

Councilwoman Goodloe thanked each of the Councilmen for all their lengthy hours of service and sharing their wisdom with her.

Councilwoman Eisenberg Knegten thanked each Councilmen for the hours and years of service they have given to the town. She also said the best part about serving in the town you live is walking out of your door and still being neighbors. She said she is looking forward to sharing that quality with her former Councilmen.

Mayor Balla thanked former Councilman Rob Gibbs for his experience and wisdom he provided to the Council. He thanked Councilman Nehls for his fortitude and responsibility when examining the Boroughs budget. He also thanked Councilman Sopko for his gift of real estate knowledge that he brought to the Administration and Finance Committee. He thanked all of the Councilmen for exemplifying what it takes to be a true public servant.

- 1. Administration & Finance Councilman Sopko said the Administration and Finance Committee met on December 6th and discussed the new policy on alcohol and drug free work place. He also said the Committee discussed personnel adjustments, the budget and expanding the Foveonics contract.
- 2. Police Councilman Nehls had no report.
- 3. Public Works / Buildings and Grounds Councilman Nehls said the leaf bag pickup has been completed, and announced that we have approximately 700 tons of road salt on hand. He also mentioned that notice was received from the State that the Borough has received \$300,000 dedicated to road grants for next year. Councilman Nehls read a formal letter of retirement from Mr. Burns effective February 29, 2020. Councilman Nehls thanked Mr. Burns for his dedication to the Borough but especially for the dedication he showed to our residents during super storm Sandy. Councilman Nehls said the Public Works Committee met and discussed a truck currently being repaired, however said it will need to be replaced in the future. Mr. Nehls also commented on the importance of the salt dome. He said the gate to the salt dome has been damaged and is being replaced. He thanked Watchung Schools' Principal Mary Nunn for her dedicated service throughout the years to the school system and wished her the best of luck in her retirement.

4. Public Affairs:

Environmental - Councilwoman Goodloe said the Environmental Commission met and they are in the process of planning for the Green Fair. She said they have recycled a total of 255 pounds of plastic out of the 500-pound goal needed towards the bench. She also said the Commission would like to be involved with the planning of the rain garden.

Recreation - Councilman Black had no report.
