Public Hearing of Bond Ordinance OR:20/01 entitled: "BOND ORDINANCE PROVIDING FOR THE CONSTRUCTION AND EQUIPPING OF A NEW LIBRARY, BY AND IN THE BOROUGH OF WATCHUNG, IN THE COUNTY OF SOMERSET, STATE OF NEW JERSEY; APPROPRIATING \$6,200,000 THEREFOR AND AUTHORIZING THE ISSUANCE OF \$5,900,000 BONDS OR NOTES OF THE BOROUGH TO FINANCE PART OF THE COST THEREOF"

Margaret Ellis, Valley Road, thanked the Council for moving forward with construction of a new Library, as it is the right thing to do.

Catherine Leigh, suggested to the Council that they "bond as they go" through the process, because we won't over-tax the Borough if the monies are not needed. She said while her husband fully supports a new Library, she personally thinks we need one, however, maybe not one this big.

With no further public wishing to be heard Councilman Jubin closed the public hearing.

Councilwoman Eisenberg Knegten made a motion to table Bond Ordinance OR:20/01.

Councilwoman Goodloe explained that after meeting with our Grant Writer, it was brought to our attention that the bond is not required for the Grant Application, and that a Resolution is equally acceptable. Council President Robinson added that a Resolution will take us to where we need to be before we need to bond. Councilman Jubin said the Borough is moving quickly for the Grant Application, and the Administration and Finance Committee had a great meeting on Monday morning with our Professionals and complimented the team for working hard. He thanked the Committee and our Consultants.
