AN ORDINANCE PROVIDING FOR LANDSCAPING IMPROVEMENTS, SIGNS, AND OTHER PROPERTY BEAUTIFICATION IMPROVEMENTS IN THE BOROUGH OF WATCHUNG, IN THE COUNTY OF SOMERSET, NEW JERSEY AND APPROPRIATING \$50,000.00 THEREFOR FROM THE CAPITAL IMPROVEMENT FUND.
