

BE IT HEREBY RESOLVED by the Mayor and Council of the Borough of Watchung, County of Somerset, State of New Jersey as follows:

- 1. Taxes shall be collected quarterly on February 1, May 1, August 1, and November 1, 2023.
- 2. Payment of taxes shall be remitted to the Tax Collector of the Borough of Watchung.
- 3. Interest shall be charged and calculated at the rate of 8% per annum on the first \$1,500.00 of the delinquency, and 18% per annum on any amount in excess of \$1,500.00 to be calculated from the date the tax was payable until the date the actual payment is received.
- 4. There shall be a 10-day grace period, after which unpaid taxes will be charged interest from the due date.
- 5. Redemption fee for Tax Sale Certificate to the Municipality as follows:
 - a. 2% on certificates \$200.00 to \$4,999.99
 - b. 4% on certificates \$5,000.00 to \$9,999.99
 - c. 6% on certificates of \$10,000,00 or more
- 6. Redemption amounts shall be obtained from the Tax Collector. The property owners shall be entitled to receive two redemption calculations free of charge per calendar year. Subsequent calculations and calculations for the lienholder shall be charged of \$50 per calculation.
 - a. Duplicate Tax Sale Certificate of Certificate of Redemption \$100
 - b. In lieu of publication, notice of tax sale to be mailed \$25 per mailing
- 7. A fcc of \$20.00 shall be charged on each returned payment.
- 8. Duplicate bill fee of \$5.00 shall be charged upon request, excluding property owners.
- 9. The Tax Collector is authorized pursuant to P.L. 1979, Chapter 82, as amended by P.L. 1996, Chapter 13 (C.40A)9-1/54.1) to cancel a refund and/or balance of any municipal charge of less than \$10.00 without further action of the Governing Body.
- 10. Be it further resolved that a 6% year-end penalty be assessed on the last day of the fiscal year on delinquent accounts when in excess of \$10,000.
- 11. The Borough Clerk is hereby directed to publish a copy of this resolution.




