

BOROUGH OF WATCHUNG - BOARD OF HEALTH MINUTES

MAY 17, 2023 AT 7:00PM

Call to Order

The meeting was called to order at 7:08 p.m.

President's Statement

Under the provisions of N.J.S.A 10:4-6 et seq., notice of time and place of this meeting has been posted and sent to the official newspapers.

Bruce Ruck welcomed Deepika Garg to her first meeting and introductions were made by Board members and Bruce Ruck gave a summary of Middle-Brook Regional Health Commission (MRHC).

Health Inspector Report

February, March and April 2023 reports (attached hereto).
 Bruce Ruck inquired of the incident of the Bat in the Post Office, whether anyone was bitten. Robyn Key responded that no one was harmed in that incident.

Robyn Key informed that the report with the stats is still in progress and that she will be adding more data. Discussion was held regarding the reporting of COVID outbreak and cases especially in long-term care facilities.

Bruce Ruck mentioned anticipated cases of Lyme Disease. Robyn Key explained that Lyme Disease is no longer considered reportable as far as investigations, but she can access numbers in the surveillance system.

Dámaris Quiñones-Gray read a statement by Kevin Sumner, Health Officer, as follows: "Please note to Members that adjustments were made beginning with April reports, as requested, to separate reports by town where possible. Prior months had already been completed. Thanks."

Health Commission Report

Robyn Key informed that MRHC has several grants in process and named the following:

- The Strike Team Grant provides infection control training in long-term and skilled nursing facilities.
- The NJ Strengthening Grant supports infectious disease and outreach coordinator staff (to be renewed for another year).
- The Health Officers Association Grant supports new MRHC health educator.

Robyn Key also mentioned that the Health Officers Association is trying to secure for a minimum of \$10 million dollars from the State for local public health agencies. She further informed MRHC hired a Health Educator - Amelia Dominguez from Long Branch who will be updating the MRHC's website to include public education material on mental health. Bruce Ruck questioned if MRHC can provide the website analytics to ascertain how many people are actually visiting.

Animal Control Solutions Monthly Reports

• March and April 2023 – Discussion was held regarding incidents reported and anticipated increase in "dog bites" in warmer months.

Old Business

Mayors Wellness Campaign – Watchung Walks
 Bruce Ruck elaborated on the attendance at this year's walks thus far. He suggested that
 the Board members take turns to be at one of the walks, maybe a schedule can be
 created.

Kimberly Brown suggested to start the walk on the other side of the lake to be more visible. She also suggested that signs need to be placed in front of Lake and Borough Hall. Discussion was held regarding initiatives to make the advertisements for walks more visible. Dámaris Quiñones-Gray provided the results to date of the survey (copy attached)
