MINUTES

On motion by Chairwoman Schaefer, seconded by Ms. Spingler, the Regular Meeting Minutes, May 16, 2023, were accepted and carried on voice vote. Mr. Troy Sims and Ms. Jackie Bodnar did not vote as they were not eligible.

ORDINANCE COMMITTEE

The Ordinance subcommittee met prior to the regular meeting to discuss an ordinance and any recommendations. The subcommittee agreed with Mr. Healy's assessment of the ordinance and asked him to present it to the board.

ORDINANCE REVIEW

ORDINANCE AMENDING THE BOROUGH'S ZONING REGULATIONS, CHAPTER 28 LAND DEVELOPMENT, TO REVISE ARTICLE 28-500 REGULATING FENCES AND WALLS.

Mr. Healy has found this amendment to not be inconsistent with the Master Plan. The Committee did have a few considerations for the Council to think about. The Committee recommends the following be looked at:

Proposed requirement that gates need to be at least 15 feet from the curb line; not sure if for esthetic reasons or to make sure when car is pulling off of road, they have sufficient room to get the car off of the street into the property to open the gate. Looking at the 15 feet if the gate opens out, is this enough room for the car to be fully off the road.

Regarding the existing ordinance; two things the Committee talked about that are not proposed to change but since they were reviewing the ordinance discussed the following:

Master Plan re-examination comment looking at fencing around pools; overall recommendation to have Construction Official look to make sure not inconsistent with the Construction Code. Zoning ordinance states you can use a building as part of the barrier to the pool, ordinarily this would not want to be addressed in a zoning ordinance as this is construction code material, make sure it is not inconsistent with the Construction Code.

Electrical fences allow up to 1,000 volts. Not something normally found in Zoning Ordinance, maybe have Construction Code Official look at this as it may already be addressed in another code.

Madame Chair motions, seconded by Mr. Speeney on the two following recommendations:

- 1. Mayor and Council look at fencing and swimming pools and voltage on fencing, review to make sure compliant with UCC and have a Construction Official review.
- 2. Look at setback of entrance gates for the purpose of not having a car encroach on a gate while waiting to open and make sure gate will not interrupt use of sidewalk.
